Schroder International Selection Fund (the "Company") – Various sub-funds as set out in the Appendix (the "Funds")

We are writing to inform you that the Funds' investment policies have been updated to permit investment in China A-Shares listed on the Science and Technology Innovation Board ("STAR Board") of the Shanghai Stock Exchange and ChiNext Market of the Shenzhen Stock Exchange. The Funds are listed in the Appendix to this letter.

Background and rationale

The Funds may invest directly or indirectly (for example via participatory notes) in China A-Shares through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and variously through the Qualified Foreign Investor (QFI) Scheme (formerly known as the Renminbi Qualified Institutional Investor (RQFII) Scheme) and regulated markets (as defined in the prospectus of the Company ("**Prospectus**")).

The STAR Board and ChiNext Market are technology based Chinese stock exchanges and have been added to increase the flexibility of the Funds' Chinese investment access.

Save as disclosed above, all other key features of the Funds, including their investment objectives and policies, risk and return profile and fees, will remain the same.

The Hong Kong offering documents of the Company will be revised to reflect the above changes and will be available free of charge at www.schroders.com.hk¹ or upon request from the Hong Kong Representative of the Company, Schroder Investment Management (Hong Kong) Limited.

科創板及創業板是以科技為基礎的中國證券交易所,並已予增設以提升基金參與中國投資的靈活性。

除上文所披露外,基金的所有其他主要特點,包括其投資目標及政策、風險及回報概況及費用將維持不變。
